SECTION E CERTIFICATION

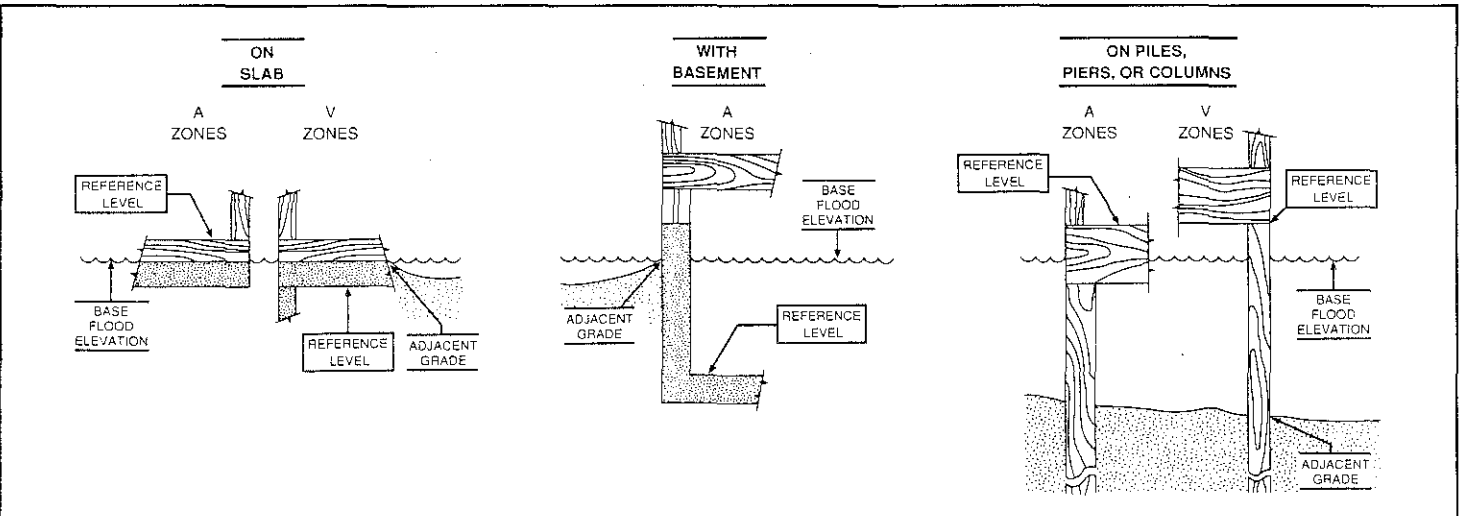
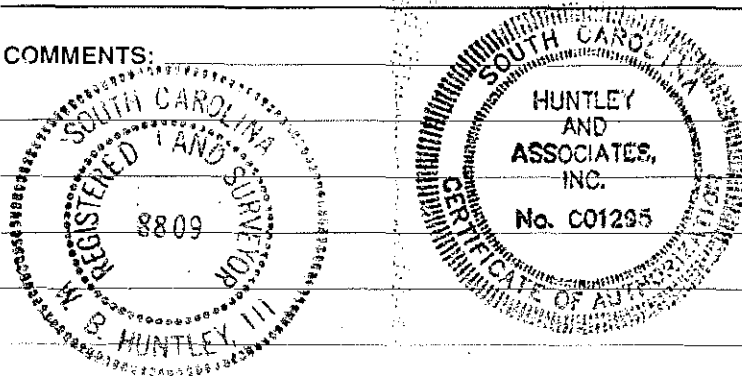
