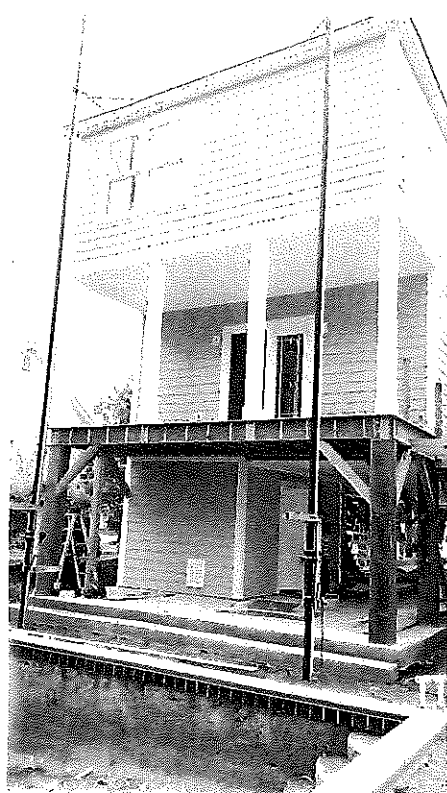

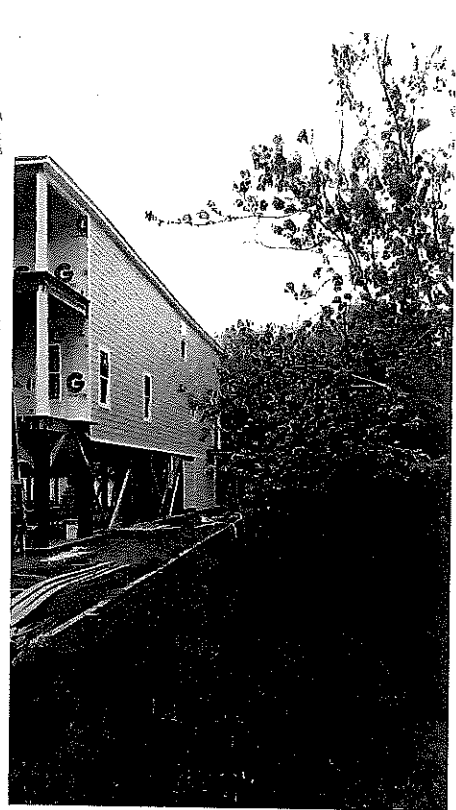

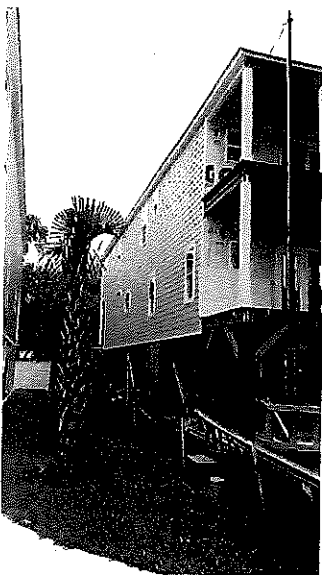
FRONT VIEW
