

STATE OF SOUTH CAROLINA) AN ORDINANCE OF THE TOWN OF SURFSIDE BEACH
COUNTY OF Horry) TO AMEND SECTION 9-9, PARAGRAPH (a) TO INCREASE
TOWN OF SURFSIDE BEACH) PARKING RATES TO TWO DOLLARS (\$2) PER HOUR AT
) ALL BEACH ACCESS PARKING AND AT YAUPON PARKING LOT

WHEREAS, the Mayor and Town Council of the Town of Surfside Beach, in council duly assembled on this 12th day of February 2019; and

WHEREAS, the Mayor and Town Council desire to amend the Code of Ordinances to increase the hourly rate for all beach access parking to conform with all other area municipalities.

NOW, THEREFORE, by the power and authority granted to the Surfside Beach Town Council by the State of South Carolina that of the Surfside Beach Code of Ordinances Chapter 9, Section 9, Paragraph (a) is hereby amended to state:

Section 9-9. - Charges. (a) *Pier parking pay stations, **Yaupon Parking Lot***, and all beach access parking east of Ocean Boulevard.* Hourly charges are hereby established at the rate of two dollars (\$2.00) per hour, plus various transaction fees and said charges are subject to annual review by town council. ***Added Yaupon Parking Lot by approved amendment 02/26/2019. D. Herrmann, CMC, Town Clerk**

SEVERABILITY. If any provision, clause, sentence, or paragraph of this ordinance or the application thereof to any person or circumstances shall be held invalid, that invalidity shall not affect the other provisions of this article, which can be given effect without the invalid provision or application, and to this end the provisions of this article are declared to be severable.

EFFECT OF SECTION HEADINGS. The headings or titles of the sections hereof shall be solely for convenience of reference and shall not affect the meaning, construction, interpretation or effect of this ordinance.

REPEAL AND EFFECTIVE DATE. All ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed. This ordinance shall take effect immediately upon second reading by the Mayor and Town Council of the Town of Surfside Beach.
