Business Discussion Topics and Proposals

1. Lanier to give cost increases to the committee if new parking areas are added to their current contract.
 - a. If all recommendations from the parking committee were implemented as Pay to Park, Text to Part or Pay Stations
 - i. Approx. 300 new spots
 - ii. Additional labor costs of 4 to 8 hours per day
 - iii. Signage for all new location including post where needed.
 - b. Cost estimates are on the high end from Lanier
 - i. 4 hours addition would be all in approx. \$18,000.00
 - ii. 8 hours addition would be all in approx. \$36,000.00
 - iii. Signage would be \$4,000 to \$6000 (est.)
2. Parking area Topics to be presented and discussed at workshop to be held at 3:00pm on April 12th.
 - a. Pay to Park at all Beach Accesses
 - b. Pay to Park at Seaside Drive
 - c. Pay to Park at Surfside Drive near library
 - d. Expand Golf Park Parking in Yaupon Lot
 - e. Add parking on 13th Ave S Oceanside parking lot and Between Ocean Blvd. and Dogwood.
 - f. Expand No Parking Zone on east side of Dogwood across from Floral Lake Ball Field.
 - g. Add Signage around ball field to make clear that parking at the ball field is just for the ball field.
 - h. Add additional golf cart parking spots to 5th Ave S. Oceanside parking lot.
 - i. Safety zone in e-district
 - j. 1st Ave South Golf cart/Motorcycle parking
 - k. Surfside drive Business district signage.
3. Topics to be discussed at next meeting

- a. Willow drive being used by Palm Resort Buses for staging/waiting area.
- b. Employee Parking Areas and how best to implement and enforce.
- c. Discuss Ocean Blvd. Pay to Park areas
