**NOVEMBER 5, 2019 GENERAL ELECTION**

**WHEREAS**, the Town Council of the Town of Surfside Beach held a General Election on Tuesday, November 5, 2019 for the purpose of electing a mayor and three councilmembers whom shall serve a four-year term beginning December 10, 2019 and ending December 12, 2023; and

**WHEREAS**, said election was duly and properly held; the returns of the election managers and the original poll list are on file in the Horry County Office of Elections and Registration, and the Election Summary Results Report is attached hereto certifying that the total votes cast were:

**WHEREAS**, the results of the **General Election** for the mayor's seat did not have any successful candidates, but that Bob Hellyer with 416 votes and Julie Samples with 404 votes received a sufficient number of votes to participate in a runoff election to fill the mayor's seat; and

**WHEREAS**, the results of the **General Election** for the three town council seats did not have any successful candidates, but that Paul Holder with 488 votes; Michael N. Drake with 444 votes; Cindy Keating with 443 votes, and Kathryn Martin with 433 votes qualify to participate in a runoff election to fill the town council seats; and

**WHEREAS**, the Horry County Election Commission deemed that a **Runoff Election** shall be held on Tuesday, November 19<sup>th</sup> between the stated candidates;

***NOW, THEREFORE, BE IT RESOLVED*** by the Town of Surfside Beach Town Council that Town Council finds that the facts set forth and the statements made herein are true and correct; and

***BE IT FURTHER RESOLVED*** that the successful candidates of the Runoff Election shall be sworn to office during the regular Town Council meeting scheduled December 10, 2019.
