

STATE OF SOUTH CAROLINA) AN ORDINANCE OF THE TOWN OF SURFSIDE BEACH
) TO AMEND SECTION 2-61(b)(iii) TO REQUIRE VOLUNTEERS
COUNTY OF HORRY) FOR TOWN BOARDS, COMMISSIONS, AND COMMITTEES TO
) COMPLETE AN APPLICATION PROVIDED BY THE TOWN
TOWN OF SURFSIDE BEACH)

WHEREAS, the Mayor and Town Council of the Town of Surfside Beach, in council duly assembled on this 25th day of June 2019; and

WHEREAS, Town Council has found during the past several year that it is difficult to properly evaluate information from those desiring to serve the town by 'brief summary of background'; and

WHEREAS, the Mayor and Town Council have determined that it is in the best interest of the town and of volunteers to formalize the submission process for those desiring to serve on the town's boards, commissions, and committees.

NOW, THEREFORE, by the power and authority granted to the Surfside Beach Town Council by the State of South Carolina that of the Surfside Beach Code of Ordinances Section 2-61(b)(iii) is hereby amended to state:

Section 2-61.

(b) (iii) Volunteers seeking appointment to any board, commission, or committee shall submit to the town clerk a completed Town Boards, Commission and Committees Application provided by the town.

SEVERABILITY. If any provision, clause, sentence, or paragraph of this ordinance or the application thereof to any person or circumstances shall be held invalid, that invalidity shall not affect the other provisions of this article, which can be given effect without the invalid provision or application, and to this end the provisions of this article are declared to be severable.

EFFECT OF SECTION HEADINGS. The headings or titles of the sections hereof shall be solely for convenience of reference and shall not affect the meaning, construction, interpretation or effect of this ordinance.

REPEAL AND EFFECTIVE DATE. All ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed. This ordinance shall take effect immediately upon second reading by the Mayor and Town Council of the Town of Surfside Beach.
