

<b>STATE OF SOUTH CAROLINA ) ) COUNTY OF HORRY ) ) TOWN OF SURFSIDE BEACH )</b>	<b>AN ORDINANCE OF THE TOWN OF SURFSIDE BEACH TO AMEND ARTICLE II OF CHAPTER 2.5, SALE AND DISTRIBUTION OF ALCOHOLIC BEVERAGES, OF THE CODE OF ORDINANCES OF THE TOWN OF SURFSIDE BEACH, SOUTH CAROLINA</b>

**WHEREAS**, Chapter 1, Section 1-12 of the Code of Ordinances of the Town of Surfside Beach, South Carolina ("Surfside Beach Code") allows for the amendment of the Code of Ordinances from time to time; and

**WHEREAS**, pursuant to its authority, the Town Council of the Town of Surfside Beach, in council duly assembled, is authorized to amend the Surfside Beach Code; and

**WHEREAS**, Town Council desires to amend and eliminate certain sections of the Surfside Beach Code relating to the sale and distribution of alcoholic beverages for clarity, and as not otherwise pre-empted by state law, in the best interests of the town; and

**WHEREAS**, Town Council sought and received a recommendation regarding the proposed amendment to Chapter 2.5 from the Chief of the Surfside Beach Police Department;

**NOW, THEREFORE**, Town Council hereby directs that Section 2.5-21 of the Town Code of Ordinances of the Town of Surfside Beach, South Carolina, is amended to add a subsection (d), and that Sections 2.5-23 and 2.5-24 shall be deleted and reserved, all as set forth in redlined changes in **Exhibit A**, attached and incorporated herein, to be codified in clean form, as amended.

**SEVERABILITY.** If any provision, clause, sentence, or paragraph of this ordinance or the application thereof shall be held invalid, that invalidity shall not affect the other provisions of this article, which can be given effect without the invalid provision or application, and to this end the provisions of this article are declared to be severable.

**EFFECTIVE DATE.** This ordinance shall take effect immediately upon approval at second reading by the Town Council of the Town of Surfside Beach, South Carolina.
